#### 3. Federal Tax Reform Update

Kevin Gilhooley, Regional Affairs Officer, provided a summary of the federal tax reform proposals in both the Senate and House of Representatives. Mr. Gilhooley focused on specific policy areas that were of special concern to the SCAG region, including the Commuter Tax Benefit, the Low-Income Housing Tax Credit, the Mortgage Interest Deduction, the Plug-In Electric Drive Motor Vehicle Deduction, Private Activity Bonds & Advanced Refunding, and the State and Local Tax Deduction (SALT). Mr. Gilhooley noted that SCAG staff had convened meetings with staff from Senator Kamala Harris' and Diane Feinstein's office to express concerns specifically on Private Activity Bonds.

#### 4. Policy & Public Affairs Update

Art Yoon, Director of Policy & Public Affairs, stated that over 140 applications were submitted for the Legislation Manager position. Mr. Yoon stated he seeks to have second-round interviews in December and the position filled by January 2018.

Mr. Yoon also stated that depending on whether or not the Continuing Resolution moved forward in Congress, there may be a need to reconvene the Legislative/Communications and Membership Committee in December. If nothing urgent emerges, the Committee would not meet until January 16, 2018.

Mr. Yoon concluded the update by recognizing the dedicated service of Jane Embry, former Senior Administrative Assistant and Clerk of the Legislative/Communications & Membership Committee. Numerous Committee Members thanked Ms. Embry for her 12 years of service.

#### **EXECUTIVE SUMMARY:**

The Legislative/Communications & Membership Committee (LCMC) is asked to approve up to \$20,000 in memberships for: 1) Southern California Leadership Council and the Center of Economic Development; and up to \$42,500 in sponsorships for the 2) Urban Land Institute Los Angeles: 2018 Urban Marketplace (\$7,500); 3) Local Government Commission 27th Yosemite Policymakers Conference (\$5,000); and 4) California Transportation Congressional Reception (\$30,000).

#### **STRATEGIC PLAN:**

This item supports SCAG's Strategic Plan: Goal 1: Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies; and Goal 2: Obtain Regional Transportation infrastructure Funding and Promote Legislative Solutions for Regional Planning Priorities.

#### **BACKGROUND:**

Item 1: Southern California Leadership Council and the Center of Economic Development

**Type:** Membership **Amount:** \$20,000

Established in 2005, The Southern California Leadership Council is comprised of business and community leaders from throughout the seven counties of Southern California, including four former California Governors.

The Leadership Council funds, prioritizes, and approves the work of the Center of Economic Development (CED), which is a regional program of the Los Angeles County Economic Development Corporation (LAEDC). As a program of the LAEDC, the CED benefits from related work of the LAEDC's acclaimed business assistance, economic research, and consulting programs. The Center's work is funded, prioritized and approved by the Leadership Council to shape and solve public policy issues such as business vitality, resources (energy, water and environment), and transportation (goods and people) that are critical to SCAG and the region's economic vitality and quality of life. The Leadership Council also co-hosts (with SCAG) the annual Southern California Economic Summit.

SCAG Executive Director Hasan Ikhrata regularly attends Southern California Leadership Council meetings along with SCAG Board officers.



Item 2: Urban Land Institute Los Angeles: 2018 Urban Marketplace

**Type:** Sponsorship **Amount:** \$7,500

The Urban Land Institute (ULI) Los Angeles 2018 Urban Marketplace will be held on March 28, 2018 at The MacArthur in MacArthur Park. The Urban Marketplace is ULI Los Angeles's flagship annual event and draws the city's top-level development professionals, including elected officials, city staff, developers, urban planners, architects, attorneys, and builders. The mission of the event is to convene dealmakers in one room for a half-day, inspirational program with plenty of time to dialogue. The Urban Marketplace is a conference and expo designed to promote real estate investment opportunities and development strategies for the Los Angeles area's lower income and higher poverty neighborhoods.

Previous events have attracted well over 400 attendees and SCAG Executive Director Hasan Ikhrata has participated as a speaker in the past. SCAG staff is recommending that the agency continue sponsorships at the "Gold" level in the amount of \$7,500, which will include the following benefits:

- One (1) half-page advertisement in the program;
- Eight (8) complimentary registrations to the conference (value of \$960);
- Eight (8) city/county tables to promote development opportunities that aligned with work resulting from SCAG's Sustainability Planning Grant program efforts;
- Priority placement on all publicity and marketing; and
- Premium exhibitor booth space.

Item 3: Local Government Commission 27th Yosemite Policymakers Conference

**Type:** Sponsorship **Amount:** \$5,000

The Local Government Commission's 27th Yosemite Policymakers Conference will be held March 15-18, 2018 at the Yosemite Valley Lodge in Yosemite National Park. This popular conference, attended by mayors, city council members, county supervisors, city managers, and other high level department heads, features a timely and inspirational agenda designed to assist California's local elected officials in finding the tools and support they need to implement innovative solutions to address society's most pressing challenges. This year's conference theme, "Building Livable Communities," will focus on which policymakers can implement innovative solutions and utilize practical strategies and accessible tools to help their communities recover from immediate economic, social, and environmental challenges while increasing longer-term community resilience to prosper in the future.

Staff is recommending a "Conference Champion" level sponsorship in the amount of \$5,000, which includes the following benefits:

- One (1) complimentary conference registration;
- Prominent logo placement in promotional materials;
- Prominent logo placement on the conference website;
- On-site acknowledgment of the agency's support during the conference;



- Logo projected on screen during sessions;
- Special discount registration code (10% off) for local policymakers within the agency's network;
- Opportunity to display up to two (2) promotional materials at the event.

Item 4: California Transportation Congressional Reception

**Type:** Sponsorship **Amount:** \$30,000

The California Transportation Congressional Reception is an event in Washington, DC—which SCAG has co-sponsored for over a decade—that is organized to present a California-focused event on Capitol Hill to celebrate with California's Congressional delegation and to thank the Congressional Leadership and Members for their support in working towards long-term solutions for our state's transportation infrastructure needs. In addition, the reception brings together everyone in California transportation to emphasize the need to work in solidarity with the new Administration to implement its ambitious infrastructure investment plans so critically needed throughout California and the nation.

This year's reception, which will be co-sponsored with the Metropolitan Transportation Commission, will be held on, Tuesday, March 13, 2018, from 5:45 p.m. – 7:45 p.m. at 2165 Rayburn House Office Building in Washington, DC. To maximize attendance, this event is scheduled concurrent with the National League of Cities' 2018 Congressional City Conference. The event typically draws about 500 guests and invitees include all of the California Congressional Delegation and staff, House and Senate Members of the Appropriations and Authorizing Committees, officials and staff from the United States Department of Transportation (USDOT), Federal Highway Administration (FHWA), and Federal Transit Administration (FTA), the Governor of California, Commissions and staff from the California Transportation Commission, and members of the business community.

SCAG staff recommends approval of this sponsorship in the amount of \$30,000.

#### **FISCAL IMPACT:**

\$62,500 for memberships is included in the approved FY 17-18 General Fund budget.

#### **EXECUTIVE SUMMARY:**

This report includes the summary and status of bills of interest to SCAG that were introduced this legislative year (beginning January 3, 2018). Staff will monitor the disposition of these and other bills on the legislative tracking report and bring forth recommendations to the committee where appropriate.

#### STRATEGIC PLAN:

This item supports SCAG's Strategic Plan: Goal 1: Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies; and Goal 2: Obtain Regional Transportation infrastructure Funding and Promote Legislative Solutions for Regional Planning Priorities.

#### **BACKGROUND:**

**Bill:** AB 1745 **Author:** Assemblymember Philip Ting (D-19)

**Title:** Vehicles: Clean Cars 2040 Act **Status:** Introduced on January 3, 2018

AB 1745 would, commencing January 1, 2040, prohibit the Department of Motor Vehicles from accepting an application for original registration of a motor vehicle unless the vehicle is a zero emissions vehicle, as defined. The bill would exempt from that prohibition, a commercial vehicle with a gross vehicle weight rating of 10,001 pounds or more, and a vehicle brought into the state from outside of the state for original registration, as specified.

Bill: AB 1759 Author: Assemblymember Kevin McCarty (D-7)

**Title:** General plans: housing element: production report: withholding of transportation funds

**Status:** Introduced on January 4, 2018

AB 1759 would require the Department of Housing and Community Development, on or before June 30, 2022, and on or before June 30 every year thereafter and until June 30, 2051, to review each production report submitted by a city or county in accordance with the provisions as specified to determine whether that city or county has met the applicable minimum production goal for that



reporting period. The bill would provide that, if the department determines that a city or county has met its applicable minimum production goal for that reporting period, the department shall, no later than June 30 of that year, submit a certification of that result to the Controller.

**Bill:** AB 1765 **Author:** Assemblymember Sharon Quirk-Silva (D-65) **Title:** Building Homes and Jobs Act: fee waiver: states of emergency

Status: Introduced on January 4, 2018

The Building Homes and Jobs Act, imposes a charge, except as provided, of \$75 to be paid at the time of the recording of every real estate instrument, paper, or notice required or permitted by law to be recorded, per each single transaction per single parcel of real property, not to exceed \$225. Current law requires a county recorder to send revenues from the charge to the controller for deposit into a fund in the State Treasury to be expended for various purposes related to homes and jobs. AB 1765 would waive that charge with regard to any real estate instrument, paper, or notice recorded in connection with real property upon which repairs or reconstruction are taking place as a direct result of a disaster for which the Governor has declared a state of emergency.

**Bill:** ACA 21 **Author:** Assemblymember Chad Mayes (R-42)

Title: State infrastructure: funding: California Infrastructure Investment Fund

Status: Introduced on January 3, 2018

Would amend the California Constitution to create the California Infrastructure Investment Fund in the State Treasury. The measure would require the Controller, beginning in the 2019–20 fiscal year, to transfer from the General Fund to the California Infrastructure Investment Fund in each fiscal year an amount equal to up to 2.5% of the estimated General Fund revenues for that fiscal year, as provided. The measure would require, for the 2019–20 fiscal year and each fiscal year thereafter, the amounts in the fund to be allocated, upon appropriation by the Legislature, for specified infrastructure investments, including the funding of deferred maintenance projects.

**Bill:** SB 827 **Author:** Senator Scott Wiener (D-11) **Title:** Planning and zoning: transit-rich housing bonus

Status: Introduced on January 3, 2018

SB 827 would authorize a transit-rich housing project to receive a transit-rich housing bonus. The bill would define a transit-rich housing project as a residential development project the parcels of which are all within a 1/2-mile radius of a major transit stop or a 1/4 mile radius of a high-quality transit corridor, as those terms are further defined. This bill contains other related provisions and other existing laws.



Bill: SB 828 Author: Senator Scott Wiener (D-11)

**Title:** Land use: housing element **Status:** Introduced on January 3, 2018

SB 828 would state the intent of the Legislature to enact legislation that would, among other things, require the department to take certain actions relating to unmet housing needs, including completing a comprehensive assessment on unmet need for each region and including the results of the assessment in regional allocations for the next housing element cycle.

**Bill:** SB 829 **Author:** Senator Scott Wiener (D-11)

Title: Employee housing: farmworker housing

Status: Introduced on January 3, 2018

SB 829 would state the intent of the Legislature to enact legislation that would expand the Employee Housing Act to: 1) further incentivize the creation of farmworker housing in agricultural communities; 2) authorize the Department of Housing and Community Development to partner private agricultural operators with independent nonprofits that will manage and operate residences; and 3) preserve and protect the civil rights of tenants living in employee housing.

#### **EXECUTIVE SUMMARY:**

President Donald Trump signed the bill H.R. 1, the "Tax Cuts and Jobs Act," into law on December 22, 2017. This report provides a summary of some of H.R. 1's major provisions, as well as an update on issues of special concern to the SCAG region, to which staff informed the Committee at the November 21, 2017 Legislative/Communications & Membership Committee (LCMC) meeting.

This item supports SCAG's Strategic Plan: Goal 1: Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies; and Goal 2: Obtain Regional Transportation infrastructure Funding and Promote Legislative Solutions for Regional Planning Priorities.

#### **BACKGROUND:**

On December 15, 2017, a House of Representatives and Senate Conference Committee released a unified version of H.R. 1, also known as the "Tax Cuts and Jobs Act." This followed passage of H.R. 1 by the House of Representatives on November 16, 2017 and by the Senate on December 2, 2017. The legislation lowers most individual income tax rates and roughly doubles the standard deduction, eliminates several tax breaks and deductions, significantly lowers the corporate income tax rate, and accomplishes several other goals of Congressional Republicans and President Donald Trump. President Trump signed the bill into law on December 22, 2017.

Most of the changes take effect January 1, 2018. Individual provisions in the new legislation technically expire by the end of 2025, though some expect that a future Congress will not actually allow them to lapse. Most of the corporate provisions are permanent.

Below is a summary of some of the major changes contained within H.R. 1, as well as highlights of issues of special importance to the SCAG region.

#### **General Overview:**

Corporate Tax Rate: The tax overhaul reduces tax on corporate earnings from 35% to 21%, effective tax year 2018. This reduction is permanent.



- <u>Child Tax Credit</u>: The Child Tax Credit is expanded from \$1,000 to \$2,000 for single filers and married couples. The tax credit is fully refundable up to \$1,400, while increasing the phase-out from \$110,000 in previous law to \$400,000. Parents must provide a child's valid Social Security Number in order to receive this credit. The Child and Dependent Care Tax Credit and Adoption Tax Credit were preserved. These changes are temporary and expire at the end of tax year 2025.
- Income Brackets & Standard Deduction: H.R. 1 lowers most individual income tax rates, including the top marginal rate from 39.6% to 37%. In addition, the legislation retains the current seven-bracket structure, but bracket widths are modified to 10%, 12%, 22%, 24%, 32%, 35%, and 37%. H.R. 1 significantly increases the standard deduction to \$12,000 for single filers, \$18,000 for heads-of-household, and \$24,000 for joint filers in 2018 (compared to \$6,500, \$9,550, and \$13,000 respectively under previous law). The personal exemption is eliminated. These changes are temporary and expire at the end of tax year 2025.
- <u>Small Business Pass-Throughs</u>: Going forward, H.R. 1 offers a 20 percent tax deduction that applies to the first \$315,000 of joint income earned by all businesses organized as S corporations, partnerships, LLCs, and sole proprietorships. Under the previous law, small businesses could have been taxed at the same individual rates as wages, which were as high as 40%. For these businesses with income above this level, the bill generally provides a deduction for up to 20% on business profits reducing their effective marginal tax rate to no more than 29.6%. These changes are temporary and expire at the end of tax year 2025.
- <u>Individual Mandate Repeal</u>: The tax overhaul effectively repeals the individual mandate in the Affordable Care Act, also known as ObamaCare. The individual mandate, requires most Americans (other than those who qualify for a hardship exemption) to carry a minimum level of health insurance coverage. This change is permanent and takes effect beginning January 1, 2019.
- <u>ANWR Drilling</u>: H.R. 1 mandates that the federal government hold lease sales in a 1.5-million-acre section of the 19-million acre Arctic National Wildlife Refuge (ANWR) in Alaska. This would open up the area to oil drilling and other energy development, lifting a 40-year-ban on development in the area. The legislation requires that the Department of the Interior conduct one sale within four years and a second within seven.

#### Issues of Special Importance to the SCAG Region:

- Commuter Tax Benefit: H.R. 1 eliminated the tax incentive for private employers to subsidize their employees' transit, parking, and bicycle commuting expenses. Previously, companies could provide parking or transit passes worth up to \$255 a month to employees as a benefit to help pay for their commuting expenses, and then deduct that cost from their corporate taxes. In addition, employers could provide a reimbursement of up to \$20 per month for reasonable expenses incurred by employees in conjunction with their commute to work by bike. The employer deduction for transportation fringe benefits was a key incentive for offering the benefit to employees.



In Southern California, over 340 companies utilized the employee commuter tax benefit to offer tickets and passes to their employees as a transit benefit. These tickets connect thousands of Southern Californians with access to our transit and bus systems, many of which may not have access without these benefits. Specifically, for Metrolink, participation in this program represents almost 20% of the system's revenues. This change is temporary and expires at the end of tax year 2025.

Low-Income Housing Tax Credit: H.R. 1 retains the Low-Income Housing Tax Credit, which encourages businesses to invest in developing and maintaining affordable housing for low-income Americans. Specifically, it provides credits to developers for costs associated with building and maintaining rental housing units for individuals whose incomes fall below average incomes in any given area.

This provision is of particular importance given our region's critical housing shortage. Since 2010, some 48,000 housing units were added to the SCAG region while taking advantage of this tax credit.

Mortgage Interest Deduction: For taxpayers who itemize, H.R. 1 preserves the home mortgage interest deduction for existing mortgages and maintains the interest deduction for new mortgages, but only for interest paid on the first \$750,000 of the mortgage. This is down from the current \$1 million. This change would apply only to mortgages made after December 15, 2017.

Additionally, interest on home equity loans will no longer be deductible after 2017. This impacts interest on all home equity loans used for purposes other than to improve the current home, even if the loan was taken out before December 15, 2017. These changes are temporary and expire at the end of tax year 2025.

- <u>Plug-In Electric Drive Motor Vehicle Deduction</u>: The tax overhaul retains the tax credit for plug-in electric vehicles. Under current law, a credit is available for new four-wheeled vehicles propelled by a battery with at least four kilowatt-hours of electricity that can be charged from an external source. The base credit is \$2,500 plus \$417 for each kilowatt-hour of additional battery capacity in excess of four kilowatt-hours (for a maximum credit of \$7,500).

The credits are available on the first 200,000 electric vehicles a manufacturer sells. Once a company reaches that threshold, the \$7,500 income-tax credit continues through the end of that calendar quarter. Afterward, it is reduced by 50% every six months until it phases out completely.

- <u>Private Activity Bonds & Advanced Refunding</u>: H.R. 1 retained the tax incentive for Private Activity Bonds (PABs) while eliminating the tax incentive for advance refundings.



PABs are debt instruments that raise capital for revenue-generating highway and freight transfer projects. PABs allow a private project sponsor to benefit from the lower financing costs of tax-exempt municipal bonds.

The tax overhaul eliminated the tax incentive for the advance refunding of bonds. Advance refunding bonds are debt instruments that allow an issuer to pay off another outstanding bond, often at a lower interest rate and with more favorable bond terms. Taxing the interest earned on advance refunding bonds will limit the ability of transportation agencies to utilize this unique financial tool, which could make infrastructure projects in Southern California more dependent on federal funding.

State and Local Tax Deduction (SALT): Under H.R. 1, taxpayers who itemize will be able to deduct their state individual income, sales, and local property taxes up to a limit of \$10,000 starting in 2018. Previously, the deduction had been unlimited. Filers have to choose to deduct either individual income taxes or sales taxes. These changes are temporary and expire at the end of tax year 2025.

#### **EXECUTIVE SUMMARY:**

H.R. 4667, authored by Congressman Rodney Frelinghuysen (R-NJ), provides \$81 billion in emergency funding for disasters caused by Hurricanes Harvey, Irma, and Maria, as well as California wildfires. This emergency funding will continue the efforts to recover, rebuild, and reduce the impact of future natural disasters. The bill was passed by the House of Representatives on December 21, 2017 and is awaiting action in the United States Senate.

#### **STRATEGIC PLAN:**

This item supports SCAG's Strategic Plan: Goal 1: Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies; and Goal 2: Obtain Regional Transportation infrastructure Funding and Promote Legislative Solutions for Regional Planning Priorities.

#### **BACKGROUND:**

H.R. 4667, authored by the House of Representatives Committee on Appropriations Chairman Rodney Frelinghuysen (R-NJ), provides \$81 billion in emergency funding for disasters caused by Hurricanes Harvey, Irma, and Maria, as well as the California wildfires. H.R. 4667 is the third disaster-related spending bill for the year and will continue the efforts to recover, rebuild, and reduce the impact of future natural disasters.

The bill was passed by the House of Representatives by a vote of 251-169 on December 21, 2017 and is awaiting action in the United States Senate.

The legislation appropriates funding along seven different categories:

#### Federal Emergency Management Administration - \$27.6 billion

- FEMA Disaster Relief Fund: \$27.5 billion to provide critical funding to assist the ongoing federal disaster response.

#### <u>Transportation</u>, <u>Housing and Urban Development - \$ 27.8 billion</u>

Community Development Block Grants Disaster Recovery (CDBG-DR): \$26.1 billion for housing and infrastructure needs.



- \$13.56 billion for grants to states, tribes, and territories for unmet housing needs and business losses.
- \$12.5 billion for mitigation efforts to help communities protect against future disasters. This funding can provide for housing elevation, buyouts in the flood plain, water/sewer infrastructure enhancements, public infrastructure hardening (e.g. storm proofing public buildings), etc.
- o Increases oversight, accountability, and transparency of CDBG funds.
- Federal Highway Administration's Emergency Relief: \$1.4 billion to address all current damages to federal highways caused by designated disasters.

#### Army Corps of Engineers - \$12.11 billion

- \$12.11 billion to repair existing damages by natural disasters and for studies and projects to reduce the risk of future natural disasters.
  - \$10.5 billion for repairs to ongoing construction projects, and to expedite construction projects that will help mitigate future disaster damage;
  - o \$370 million to repair damages along the Mississippi River and its tributaries;
  - \$608 million for Operation and Maintenance to repair damages, such as dredging of navigation channels;
  - o \$537 million for Flood Control and Coastal Emergencies to repair damages; and
  - o \$75 million to expedite studies to help mitigate future disaster damage.

#### Labor, Health & Human Services, and Education - \$3.99 billion

- Hurricane Education Recovery: \$2.9 billion to help displaced students get back to school.
  - o Funding can be used for both public and private schools.
- Provides additional funding for public health response activities.

#### Agriculture - \$3.8 billion

- Crops: \$2.6 billion in agriculture assistance, including citrus.
- Emergency Watershed Protection: \$541 million for watershed and flood prevention efforts.
- Emergency Conservation: \$400 million.
- Rural Development: \$165 million for rural water and waste disposal systems.

#### Small Business Administration Disaster Loans - \$1.66 billion

- To assist small businesses and homeowners repair or replace real estate, personal property, machinery and equipment, and inventory and business assets.

#### Defense Facilities – \$1.5 billion

- Repairs Army, Navy, Marine Corps, Air Force, Reserve, National Guard, Coast Guard, and medical military facilities.

#### **EXECUTIVE SUMMARY:**

SCAG is working on an update to its Public Participation Plan. This update will allow SCAG to reflect changes in communication technologies and public engagement best practices, as well as ensure compliance with state and federal regulations. SCAG's Public Participation Plan was last updated in March 2014, and in preparation for the development of the 2020 Regional Transportation Plan/Sustainable Communities Strategy (RTP/SCS), SCAG seeks to ensure that the agency's approach to public engagement is current, effective, and inclusive.

SCAG is engaging regional stakeholders to solicit feedback on SCAG's outreach efforts and public participation processes that will inform the Draft 2018 Public Participation Plan currently under development. Staff will make the 2018 Draft Public Participation Plan available at the February LCMC meeting, and will then seek approval to release the document for a 60-day public review and comment period.

#### **STRATEGIC PLAN:**

This item supports SCAG's Strategic Plan: Goal 1: Improve Regional Decision Making by Providing Leadership and Consensus Building on Key Plans and Policies.

#### **BACKGROUND:**

Since its inception, SCAG has engaged in a public involvement process in developing its regional transportation plans and programs. SCAG's Public Participation Plan serves as a guide for both SCAG's public involvement process as well as the continuing, comprehensive, and coordinated planning process among stakeholders to ensure ongoing opportunities for broad-based participation by as many affected and interested parties as possible in the development and review of regional plans and programs.

Strategies and best practices for public engagement, as well as the ways people consume information, continually change over time; periodic updates to the Public Participation Plan allow SCAG to better reflect those changes as well as ensure compliance with state and federal regulations. SCAG's Public Participation Plan was last updated in March 2014, and in preparation for the development of the 2020 RTP/SCS, SCAG seeks to ensure that the agency's approach to public engagement is current, effective, and inclusive.



SCAG's planning work serves a large and diverse region and relies on public participation as an essential component of our planning process. To that end, SCAG is engaging regional stakeholders to solicit feedback on SCAG's outreach efforts and public participation processes. A brief survey has been distributed to newsletter subscribers, individuals, and groups that attended public outreach workshops that were part of the 2016-2040 RTP/SCS development process. Stakeholder responses will inform the Draft 2018 Public Participation Plan currently under development.

Staff will make the draft Public Participation Plan available at the February 2018 LCMC meeting and will then seek approval to release the 2018 Draft Public Participation Plan for a 60-day public review and comment period.

If the Draft Public Participation Plan is recommended for release for public review at the February 2018 LCMC meeting, the 60-day comment period would close in April. Following the public review and comment period, staff will review, address, and incorporate—as appropriate—all comments received into a final draft. This Proposed Final 2018 Public Participation Plan would then be presented to the LCMC at their May 2018 meeting, and if recommended for approval, would then go before the Regional Council in June 2018 for final adoption.

Funding to support the development of the Public Participation Plan is identified in the agency's Overall Work Program (OWP) in 090-0148.01, Public Education and Participation.
